**Contractual Appointment of Facilitator for Conducting  
DAESI Programme (Year 2023-24)**

1. The applications are invited by the ATMA, Supaul, Bihar from Agri-Professionals to work as Facilitator in ATMA-Supaul District for conducting Diploma in Agricultural Extension Services for Input Dealers (DAESI) programme. The appointment will be done on contractual basis for 01 year and can be renewed based on performance and target available for next financial year 2024-25. Facilitator will be selected on the following criteria -
  - Graduate/Post Graduate in Agriculture/Horticulture with minimum 3 Years Experience in Agriculture or Allied Sectors. **Preference would be given to Agriculture Graduates having an experience of around 20 years in Department of Agriculture, SAUs or KVKs with sufficient Field Experience. Candidate must not have attained the age of 65 Years.**
  - The candidate should have adequate knowledge about the agricultural activities undertaken in the Districts, Experience in organising Training Programmes.
  - The candidates must have Good Oral and Writing Communications Skills and should be capable of mobilizing Input Dealers for DAESI Programme.
  - The candidate should be proficient to handle the Computers, Smart Phones and to independently manage the Documentation and Database management of DAESI Programme.

4. The Interview will be organized on **03.11.2023** at **11:00 AM** in the Office of the District Agriculture Officer Supaul by the Constituted Committee.

If any application is not obtained or any applicant is not found qualified as per norms then concerned Project Director, ATMA will again publish advertisement in newspaper and then complete the Selection Procedure by obtaining the applications and fix another date for interview with the approval of concerned District Agriculture Officer-Cum-Chairman District Level Selection Committee.
